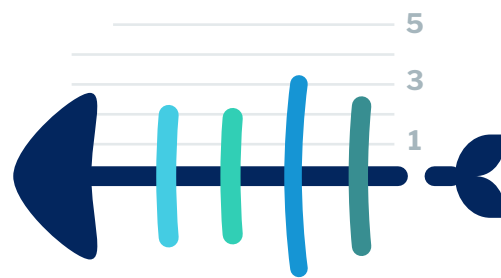

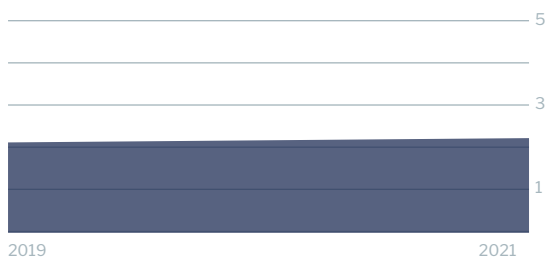

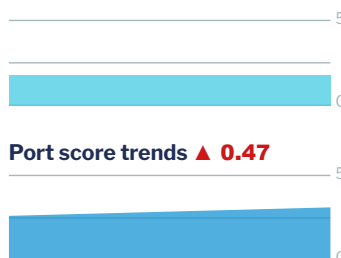

2019 - 2021 change ▲ 0.10



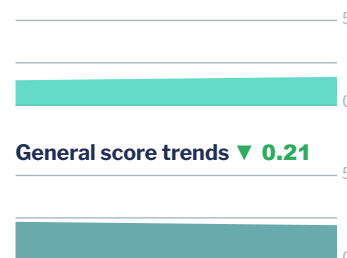
**Coastal score trends — 0**
